POLICY 154 - APPOINTEES: At the first meeting in December, the Chair shall appoint or provide for the selection of members as necessary to the organizations, committees, and councils as may be required by law, School Board policy, or as desired by the School Board. Annually at a meeting to be held in August or September, the School Board shall elect one (1) member to serve on the county value adjustment board, and appoint one (1) citizen member who owns a business occupying commercial space located within the School District to the value adjustment board.

POLICY 149.2 - BOARD MEMBER PARTICIPATION AT DISTRICT COMMITTEE MEETINGS: The School Board believes that the involvement of stakeholders in the formulation of recommendations to the Superintendent and the School Board is essential to good decision-making. If a School Board member attends a committee meeting other than a Professional Services Advisory Committee meeting, it shall be as an observer to ensure that the presence of School Board members at committee meetings does not unduly influence or stifle committee deliberations.
